- The bus fee contributes towards the transportation of students to a variety of school events including, Masses, Retreats, House events, and PE lessons.

## SUBJECT LEVIES

- Subject levies are charged to offset the additional expense and resource-heavy nature of specific subjects, such as Art, Materials Design and Technology, Food Technology and Outdoor Education. **The elective subjects offered are subject to change at any time.**
- Any students transferring into or out of an elective subject **before** the School Curriculum and Standards Authority deadline in Semester 1 or 2, will incur charges of, or be refunded 100% of the subject cost, whichever is applicable.
- All students in Year 11 who commence a Certificate course will be charged a \$150 additional course fee. This is to assist the College with the cost of the additional resources and auspicing costs associated with these courses. The fee was outlined in the Year 11 Handbook presented to students at the parent information evening.

## DISCOUNTS

Families with more than one child at the College receive discounts on tuition fees, per annum, as outlined below:

- All students and families are eligible for sibling discounts including families who receive automatic tuition fee discounts as holders of eligible means tested family concession cards.
- Any applicable discounts for multiple children will be applied to the child in the lowest year level.

## SPLIT BILLING

Families who wish to split their account equally between two parties must provide written advice to the College, **signed by both parties**, authorising the account to be divided equally. # 2018 FEES SCHEDULE

## PAYMENT OPTIONS

### Option 1

Payment of all fees, levies and charges in FULL in one instalment by **11 April, 2018**. This option is available via direct debit or creditcard. Alternatively, payment may be made by cash, cheque or by direct deposit into the College bank account.

### Option 2

Payment of fees, levies and charges in three (3) equal instalments, due on **14 March, 13 June and 12 September, 2018**. This option is available via direct debit from bank accounts using the Direct Debit Scheme or by providing the College with your credit card details for automatic payment on the dates specified. In addition, payment may be made by cash.

### Option 3

Payment of fees, levies and charges in nine (9) equal instalments, due on the **14 March 2018 and each month thereafter through to 14 November 2018**. This option is only available via Direct Debit from bank accounts using Direct Debit Scheme or by providing the College with your credit card details for automatic payment on dates specified.

### Option 4

Payment of fees, levies and charges in eighteen (18) equal instalments, due on **14th March 2018 and fortnightly thereafter through to 7 November, 2018**. This option is only available via direct debit from bank accounts using the Direct Debit Scheme or by providing the College with your credit card details for automatic payment on dates specified.

### Option 5

Payment of fees, levies and charges in thirty-six (36) equal weekly instalments, due on **14 March 2018 and weekly thereafter through to 14 November, 2018**. This option is ONLY available via direct debit payment plan.

**All Year 12 fees must be paid in full by the end of Term 3 (21 September, 2018).** Contact must be made with the College Business Manager to vary the payment method. Fee concessions may be provided to parents/guardians showing evidence of financial hardship to the Principal.

## HEALTH CARE CARD SCHEME

The discounted tuition fee covers tuition fees only to a limit of \$1,500 and does not cover additional charges such as the Friends of St Luke's Fee, Voluntary Building Fund donation and camps, book hire, excursions, etc. The discounted Compulsory Building Levy amount is \$247.

To access the Health Care Card Tuition Fees Discount Scheme:

- Parents/Guardians will need to show a valid Health Care Card or Pensioner Concession Card.
- Applications close – 1 April 2018.
- Holders of cards that are due to expire prior to the end of Term 3 will need to show their new card once issued for the discounts to continue.
